**MEETING HIGHLIGHTS**

*(Please note that these meeting minutes are a brief summary and are not the final approved version.)*

**SELECTBOARD**

10/03/16. Present: B. Brooks, N. Tift, R. Regula, and G. Fredette

There was a discussion regarding Joe Lattuca's request the Selectboard call for a Board of Abatement meeting so Mr. Lattuca could address the BOA's decision regarding his 2015/2016 Hull Avenue property taxes. No action was taken.

Brian Ferguson made his concerns known about the Witham property at 1631 Route 103.

Trudy Dias reported water runoff from Nash Drive Extension was impacting her property despite the town's past efforts to improve the situation.

Phil Baker said the Earl Wade Road culvert replacement project was completed under budget and the work was approved by the state Agency of Natural Resources. He also reviewed the state regulations regarding discharge into floor drains in relation to the town garage.

The Selectboard, along with assessor Lisa Garcia and head lister Dave Ballou, discussed the possible elimination of lister positions in favor of a hired assessor.

The Board met in executive session to discuss legal representation through the court on Frank Chapman's appeal of his property assessment.

The board reviewed several documents submitted by Ann Tiplady related to her request that the lister card on her 328 Hartsboro Road property reflect "four" bedrooms rather than three, as the issue is preventing her from finalizing a sale of the property. Ms. Garcia advised the listing should follow the legal permitting for the property. Following a lengthy discussion with her attorney as well, it was voted that the lister card will be changed as of 2017.

The board would like to discuss the Prudential Committee's candidate for appointment with one of the members.

The Selectboard approved Zoning Administrator Jeff Biasuzzi's request to attend a VLCT Zoning and Planning workshop.

At the request of VTrans, the board agreed North End Road had a three rod right of way as indicated by the Road Commissioner Phil Baker and Road Foreman Steve Lanfear.

The board reviewed the annual VLCT PACIF renewal

application and made some coverage adjustments.

G. Fredette will represent the town at the dedication ceremony for the new monument at Veterans Memorial Park.

The board approved J. Biasuzzi's request that PC members Erika Berner and Jill Burkett attend the VLCT zoning workshop too. Ms. Burkett requested the town consider stipends for planning commission members.

10/17/16. Present: B. Brooks, N. Tift, R. Regula, and G. Fredette

The Selectboard received clarification from Prudential Committee member Scott Sendra that C. Gauthier is no longer an active member and treasurer of the Wallingford Volunteer Fire Department. Therefore, it would affect his participation in discussions and votes on fire department matters if he served on the Committee. Mr. Gauthier's appointment failed to pass by a vote.

Joe Lattuca raised the issue of meeting with the Board of Adjustment so he could address their decision on his Hull Avenue property. After a lengthy discussion, the Board agreed not to schedule a meeting, recommending that he mail his concerns to each member or attend a future meeting of the BOA.

Amy Gilbert voiced her concerns regarding Delinquent Tax Collector Lee Perry's lack of response to her questions concerning her late tax payment.

First Quarter Financials were reviewed with most line items were operating around the 25% target.

Ralph Iovino and Kevin Mullin were appointed to the Planning Commission. Jeff Biasuzzi offered to serve as an alternate to keep membership at an odd number.

There was a discussion regarding the Rutland- Co. Sheriff Department's recent animal cruelty investigation.

The board did not want to see logging truck using Railroad Street as an alternative to maneuvering the intersection at Route 7 & 140.

**CONSERVATION COMMISSION**

09/26/16. Present: M. Pramuk, D. Scranton, C. Macleod, D. Klock, and R. Nimitz

Stone Carver Kerry Furlani has begun carving.

Invasive plants were pulled in the parking area and will continue with selective pulling next summer. Hopefully, John McClallen can mow 1/3 of the meadow adjacent to the parking area this fall. Another third will need to be mowed every fall.

David Baasch is knowledgeable about bees and may be willing to help.

Work Day scheduled for October 2<sup>nd</sup>.

YTD expenses vs. budget were discussed.

The CC feels it is important to protect the narrow wetlands along the twin bridges for habitat, food source and as a flood plain, although it does not appear to be suitable for development. If WCC could control, we could create a canoe portage around the pipes and manage the area with grant funding. Consult with Shannon Pytlik.

Beavers are building a dam south of the canoe launch. Shannon Pytlik will be consulted.

Upcoming programs of interest were discussed.

**PLANNING COMMISSION**

10/03/16. E. Berner, J. Biasuzzi, C. Martin, and J. Burkett

E Berner reported that the Selectboard approved the Resolution in order to apply for a Municipal Planning Grant. She and the Town Administrator are able to access the website to upload the proposal.

E. Berner reported on her meeting with Ed Bove (RRPC) concerning the grant application, what needs to be addressed and how. The PC will need to write the grant proposal. The deadline is 10/31.

**PRUDENTIAL COMMITTEE.**

09/28/16. Present: S. Sendra and K. Stocker

The Fire Department had their hose testing done and six hoses failed the testing. They would like to replace the six as well as purchase the fire nozzle that is budgeted each year. Mark Barone submitted quotes as well as Maureen, and after some discussion, the Committee approved the purchase from Fire Hose Direct.

The board read over the questions that the Selectboard had regarding the candidate for the Prudential Committee appointment. It was confirmed that C. Gauthier would be able to discuss and/or vote on any fire department issue as he is no longer an active member.

The Committee reviewed Chris Hayes' quote to have the MISSION self-dialer system installed at both the sewer plant and South Main Street Pump Station. The new system would alleviate us from having to go to South Main Street daily and would provide a better alert system. The Committee approved the purchase.

Scott talked with Thomas Jones about the chimney work at the lodge and caretaker's cabin. Mr. Jones estimated it would cost approximately \$800-\$1,000 to have both chimneys completely grouted. The Committee approved the purchase.

**10/12/16.** Present: S. Sendra and K. Stocker  
Scott will attend the next Selectboard meeting as they still have a few questions concerning the appointment to the Prudential Committee.

Scott saw the work that was done on the chimneys at the Wallingford Lodge and caretaker's cabin, and it looks great.

The new dialer system was ordered and a schedule is being worked out to get them installed. This system will be more cost effective than what we have at this time.

The board went over all the monthly financials and signed off on them.

Maureen presented the snowplow bid of \$3,800 for the upcoming season (same price as last year). This includes plowing all of our sites, around all hydrants and sanding at the fire house. The Committee approved awarding the contract to Old Skool Services again this year.

Maureen showed the Board a storage shed that Gary would like to purchase for the lodge in order to store the lawn mower and other equipment through the winter. The Board approved the purchase from Home Depot.


#### **Wallingford Veterans Memorial**

The dedication of Wallingford new Veterans Memorial Park took place on Sunday, October 9th. In December of 2015, Wallingford American Legion Post #52 was approved to receive a M114A2 Howitzer as a "Conditional Deed of Gift" from the United States Army. Our intent was to make this static display the focus of a memorial to honor the men and women of our military services who courageously served our country and to recognize the loyal support and sacrifices of their families.

Prior to approval, the Army mandated specific requirements for a permanent concrete pad to support the weight (12,800 lbs.) of the cannon and carriage. Due to cold weather conditions, we were unable to meet the requirements and risked losing the opportunity of acquiring the Howitzer. Fortunately, the U.S. Army 424 Engineer Company offered to provide a secure storage location at their Rutland facility. The Army Donations Program subsequently waived the requirement and agreed to the proposal. We then made arrangements to have the Howitzer transported from Baltimore, MD. to Rutland.

In early spring, we were finally able to break ground and go to work. Although the majority of funding for the project was raised by our own members, we could never have achieved our goal without the generous help from local businesses, contractors, and private citizens. The support we received was overwhelming and included donations of material as well as the expertise and operation skilled machine operators.


**Vote for Rodrigue**


