MINUTES OF THE PRUDENTIAL COMMITTEE MEETING

Called to Order:

The dates for all budget meetings was discussed and Maureen did say we had to have the Fire Protection done by the first week of February so it can go in the town's annual report. After some discussion the dates were set as followed: Fire Protection on Thursday, January 22nd, Lodge on Monday, February 9th, General on February 23rd, and Water/Sewer on Monday, March 2nd.
