Planning Commission (P.C.) Meeting Minutes
June 10, 2019 Town Offices, 75 School St.

The Meeting was called to order by E. Berner at 7:15 p.m. and audio was electronically recorded.

Review of Agenda

E. Berner requested a Motion to accept the draft Meeting Agenda. J. Burkett so Moved to accept the Agenda. K. Mullin seconded the Motion, all approved and Motion passed.

Approval of Minutes

E. Berner then asked for a Motion to approve the 13 May, 2019 Minutes with the corrections that she had sent to Members. K. Mullen Moved to accept the amended Minutes, J. Burkett seconded, all approved and Motion passed. *ZA Note: the March 11, 2019 Minutes remain unapproved as J. Jankus was not present to participate.*

Member Resignation

E. Berner noted the Resignation Letter by Dan Alcorn, that was accepted by the Select Board at its 6/3/19 Meeting. PC Members expressed their Thanks to Dan for his time and interest in Wallingford affairs, and wish him well.

Discussion on Candidate Interest to serve on the PC

Mr. T. Masuck has submitted a written interest in serving on the PC. J. Burkett relayed that W. Brooks III had also volunteered to serve. A call to Mr. Brooks during the meeting confirmed his offer to participate. E. Berner requested a Motion to forward a recommendation to the Select Board, to appoint W. Brooks as a Regular Member, and appoint T. Masuck as the First Alternate Member. K. Mullin so Moved, E. Berner seconded; all approved and Motion passed.

Discussion/ Updates of Zoning Regulations to comply with Town Plan

E. Berner had reformatted and emailed the Draft version of Article II (Definitions) to Members prior to the Meeting. The Members present continued review of these Definitions, working through to "Zoning Permits." The PC will focus on corrections and clarification to other Articles, in their order, at their next meeting.
