The Board reviewed the written request by Mrs. Auer asking for abatement of taxes because of a fire at her home on February 11, 2018.

O'Shea Insurance Agency declared the residence a total loss. The current lister card provided by Assessor Lisa Wright showed a house value of \$149,000, land value at \$23,800, site improvements valued at \$12,000, and the barn value at \$12,000 totaling \$190,300. The new property value will be lowered to \$41,300 as of February 12, 2018.

L. Edmunds made a motion to lower the value to \$41,300 and approve the abatement of taxes based on the "house" value of \$149,000 from 2/12 through 6/30. R. Barker seconded the motion. The motion passed unanimously.

## Ida Peck #0380631- Mobile Home Only

DTC Lee Perry reported that the land, owned by Ted Peck, that this mobile home was located on was sold by tax sale in late 2015. Since then, the bills for this mobile home have been mailed to the funeral home that oversaw Mr. Peck's funeral arrangements. The new owner removed the mobile home after the tax sale, and there is no way to collect the past due taxes. Mr. Perry asked to abate a total of \$681.53 that covered 2001, 2003, 2005-06, 2006-07, 2007-08, 2008-09, 2009-10, 2010-11, 2011-12, 2012-13, and 2013-14. R. Barker made a motion to abate the taxes on this mobile home in the amount of \$681.53. S. Thayer seconded the motion. The motion passed unanimously.
