She stated that she didn't having a problem helping out to maintain them as there are areas that need to be fixed, but she wants the Town to acknowledge that they are responsible for the Sidewalk maintenance and repair. Bill stated he has not yet been scheduled to attend a Selectboard meeting but would be doing so in the near future to discuss. Since we are having the Budget meeting now, he stated that something should be added to the budget if they were to do so. Bill made a motion to add $\$ 2,000$ to a new line item for Sidewalk Maintenance that would be given to the Town for that purpose. Kevin seconded the motion, with no further discussion, the motion carried (2-1). The new budget was set and will be added to the warning for approval at the Annual Meeting.
