# Wallingford Fire District \#1 MINUTES OF THE PRUDENTIAL COMMITTEE MEETING June 1, 2022 

## Called to Order:

Kandie called the meeting to order at $6: 06 \mathrm{pm}$ with Bill Brooks, Kevin Vaughn and Marianne McClure, the clerk/treasurer present.

## Agenda Additions/Deletions:

The Crane Deming pump at the Sewer plant that was installed in 2011 is in need of repair. The stator was full of grease and requires a steam clean and bake and the shaft sleeve has significant wear and needs to be replaced. The cost of the repair is $\$ 2,260$ and will take roughly $2-3$ weeks to repair. A new pump would cost between $\$ 8,000-\$ 10,000$. Kevin made a motion to approve the repair, Bill seconded it. With no further discussion the motion carried (3-0).

Marianne stated that she had a request to keep the Lodge open for a wedding on November $11^{\text {th }}$. The potential renter asked that the board review her request. Kandie made a motion to deny the request as there is no heat in the Lodge and that the water needs to be shut off before the pipes freeze. Kevin seconded the motion. With no further discussion the motion carried (3-0).
